IF YOU ARE A VICTIM OF IDENTITY THEFT

ACT QUICKLY

(THIS CAN HELP LIMIT DAMAGE)

IMMEDIATE STEPS

1. Call any business where you know that fraud took place. Ask to speak with their fraud department. Tell them that your identity was stolen. Ask for your account(s) to be closed or frozen so an identity thief cannot add new charges.
2. Place an initial fraud alert on your credit reports. Contact 1 of the three credit reporting agencies to report yourself as a victim of identity theft and to place the initial fraud alert. The one that you contact must tell the other two agencies. Ask the credit reporting agency for confirmation that this will be done. (A fraud alert on your credit report lets lenders and creditors know that they should take steps to verify your identity before they issue you credit. This may help prevent identity thieves from opening new accounts in your name. Initial fraud alerts are good for 90 days and may be renewed. You can later choose to place an extended fraud alert or a credit freeze.
3. Order a credit report. You are entitled by law to a free copy of your credit report once a year from all three credit reporting agencies. You must contact each agency directly to order your free reports. Some people will order from one now and then in a few months from the second agency and then in a few more months, the third agency. This will help to track any new activity on a regular basis and give you a better chance of disputing and getting any errors corrected.
4. File a complaint about the theft with [IdentityTheft.gov](https://www.identitytheft.gov). Be very detailed by providing as much information as possible. Save and print the completed complaint and print it out. This becomes your Identity Theft Affidavit. Make sure that you keep a record of the day you filed the complaint, your reference number, and have a few copies of the complaint. Any needed updates at a later date will require the reference number.
5. File your police report. Have a copy of your Identity Theft Affidavit and any other proof of the identity theft. You will also need proof of your address and a government issued photo ID.
